investments are made in internal funds and mainly through lux | funds. ## **Investment Policy**

The aim of the Mix BALANCED strategy is long-term portfolio growth with relatively limited risk. This strategy's assets are invested primarily in equities, bonds and/or money market UCI or in similar products and/or liquid funds. The strategy's anticipating average equity weighting is 40% over the long term, depending on market trends. This type of investment is suitable for investors seeking medium and long-term capital growth.
